Patient Authorization for Photographs, Video Recording, Prepared Statements and Interviews

I hereby authorize the use and/or disclosure of my individually identifiable health information as described below. I understand that this authorization is voluntary. I understand that the released information may no longer be protected by federal privacy regulations and could be subject to redisclosure. This form does not authorize redisclosure of medical information for mental health, substance abuse or HIV-related information beyond the limits of the consent. Where information has been disclosed from records protected by federal law for alcohol/drug abuse records or by state law for mental health records, federal requirements (42 C.F.R. Part 2) and the state requirements or (Iowa Code ch.228) prohibit further disclosure without the specific written consent of the patient, or as otherwise permitted by such law and/or regulations. A general authorization for the release of medical or other information is not sufficient for these purposes. Civic and/or criminal penalties may attach for unauthorized disclosure of alcohol/drug abuse or mental health information.
