Bringing a fresh new space, located just a few steps from our labor and delivery suites, the C-Section Suite will deliver an expanded, dedicated operating room for mom and baby, a stream-lined layout, enhanced functionality, and new equipment.

With 623 births in 2024, Finley Hospital is not just a hospital, but a preferred choice for an exceptional birthing experience.





Rest assured that as we prepare to deliver a state-of-the-art C-Section Suite, Finley Hospital will remain at the ready to continue to provide an exceptional experience for your new arrival.

The Family Birthing Suites currently features:

- 12 labor and delivery suites
- 4 bed Neonatal Intensive Care Unit (NICU) designated as a Level 2 Nursery caring for infants 34 weeks gestation and higher
- Enhanced Infant Security System

Finley Hospital's Family Birthing Suites team cares for newborns who require oxygen, IV therapy, phototherapy for high jaundice levels, monitoring, and other special needs.

The newborn nursery and NICU are staffed by three Neonatal Nurse Practitioners (NNPs), who provide around the clock care. Onsite NNPs ensure the best care to the youngest population. By providing constant surveillance, we are keeping more newborns local, rather than transferring them to a higher level of care facility, allowing the family unit to stay together.
