Inside this issue of *GRMC in Focus*, you will find some exciting news about the *Delivering Our Future* capital campaign to expand and renovate our obstetrics (OB) unit. Community support of this critically needed project is making a real difference for the growing families we serve. And the need becomes more pressing every day.

With the closure of MercyOne Newton's obstetrics (OB) unit last fall, we are already seeing an increase in families from Jasper County choosing to deliver their babies at GRMC. In January, our OB team delivered 33 babies, more than double the number of babies born in January 2024. February continues the upward trend, as our team delivered 30 babies compared to 20 babies in February 2024. What an exciting sign of growth for our OB unit!

We are very grateful for the support we've received to date, but we are not done fundraising yet. A bid has been accepted, a contractor has been selected, and work is expected to begin in the second quarter of 2025. This will be a multi-phased project so the unit can continue to deliver babies and care for patients throughout the construction process. The first phase is expected to be completed in 2025.

#### PUBLIC HEALTH STRIVES TO SAVE LIVES IN POWESHIEK COUNTY

Two important Public Health initiatives have begun and both have the potential to save lives in our communities.

Automated external defibrillators (AEDs) are being placed in outdoor locations around the county. Purchased with Public Health Emergency Preparedness Funds, the AEDs are protected in climate-controlled, safe boxes that are accessible by calling 9-1-1- to unlock the



box. 9-1-1 will direct the caller to dial in a one-time code to unlock the box. By installing these devices in the community, a gap is secured providing individuals with 24/7 access to a life-saving device. Initial locations for the AEDs are Ahrens Park and Central Park in Grinnell, and Diamond Lake in Montezuma. Plans include adding 3 more around the county when funding is available.

Naloxone boxes and vending machines are also being placed in outdoor locations throughout Poweshiek County. Naloxone is a medicine that rapidly reverses an opioid overdose. It can quickly restore normal breathing to a person if their breathing has slowed or stopped because of an opioid overdose but has no effect on someone who does not have opioids in their system.

Naloxone boxes contain Naloxone and education in how to use the drug. The boxes will also provide sharps containers. There is no fee to access the boxes. They are located at the County Courthouse in Montezuma, the lowa Valley Community College Campus in Grinnell, and the Brooklyn Library.



Naloxone vending machines are located at the Drake Library in Grinnell and on the Grinnell College campus. The vending machines (which do not require money to access the items inside) contain Naloxone and sharps containers as well as a variety of hygiene items and first aid kits to help with other harm reduction strategies.



"By making Naloxone easily accessible in public spaces, we reduce the barriers to timely intervention for those who may be experiencing an opioid overdose," states **Brooke Holder**, manager of Public Health. "This initiative empowers community members to act in emergency situations and fosters a compassionate and proactive approach to public health. Ultimately, Naloxone boxes are a simple yet powerful way to protect individuals, reduce stigma, and strengthen the safety and resilience of our communities."
